#### READING OF THE MINUTES

Moved by Tom Corless, Seconded by Lois Duke that the Minutes of the Executive Meeting of January  $18^{th}$  2018 be adopted as circulated. Carried

# COMMITTEE REPORTS

**FINANCE COMMITTEE** - No report. Lois advised that Jim Woods is obtaining a Land Titles record for the Lodge.

#### MANAGEMENT COMMITTEE

**Moved** by Tom Corless **Seconded** by John Hentschel that an electronic sign be purchased for \$500. **Carried**.

Lois reported that a technician from Ayeborn looked at the large screen and will come back with another technician on Friday to look at the canister.

# **ENTERTAINMENT COMMITTEE** - Andrew presented his report - see attached.

- When there is an event on a Saturday night and decorations need to be taken down from the stage area towards the end of the evening, an announcement is to be made explaining that this is being done for a hall rental on Sunday morning and patrons are welcome to stay and continue to enjoy the evening.

- A policy that that there are to be no Reserved Tickets was decided at the General Meeting on February 13<sup>th</sup>, 2018 and the Bar Committee will be informed.
- The caterer who provided the Valentine's Dinner would like to serve dinner at a cost of \$15 per person once or twice a month. It was agreed to give it a try and Andrew will work out the details of ticket sales and perhaps a "work flow" electronic sign up sheet.
- An email has been received offering to provide afternoon dance lessons and after some discussion it was agreed that Andrew will follow up.

# **PUBLICITY** - Emily reported as follows:

- She has put a photo of Geoffrey on the website and he will provide some text.
- It was suggested that more recent photos of Emily making cheque presentations, etc. be added to the website.
- She explained that Instagram allows for short "stories" that can be archived and she did some at the Valentine's Dance. She is aware of the privacy issues of taking photos.

## **NEW BUSINESS**

1. <u>60<sup>th</sup> Anniversary</u> - Andrew advised that the Entertainment Committee proposes that a celebration be held on April 14<sup>th</sup>, 2018. It is anticipated that 60 tickets will be sold at \$20.00 totalling \$1,200, and finger foods will be served. Greg Hampson has offered to play for \$200 (usual charge is \$300). Nine dignitaries plus significant others, totalling 18, will be invited. The Executive was confident that this event can be held on a break-even basis.

## 2. Complimentary Drinks

Geoffrey advised that he had received an email from Jim Mackie regarding complimentary drinks at the Robbie Burns event. Following discussion, support was shown for the Treasurer and it was agreed that Geoffrey would meet with Jim Mackie and John Hentschel.

**Moved** by Andrew Pothier **Seconded** by Ken Thibeault that volunteers should receive one complimentary drink per day for volunteering unless otherwise authorized by the President. **Carried** 

It was noted that complimentary drinks are given to members on initiation and on birthdays, and also to visitors who are members of Elks Lodges from outside the Lower Mainland. Leah suggested that a Bar Manual would help in communicating these practices.

# 3. Reserved Tables

**Moved** by Andrew Pothier, **Seconded** by John Hentschel that the policy for open-seated events as stated on the web site "You can reserve a table if you purchase 6 or more tickets at once" stands. **Carried** 

It was agreed that a diagram of the numbered tables will be put in the box for each event so that the person reserving the table can put their name on the selected table. Andrew will make up some more Reserved Signs.

# 4. Family Games Night

Moved by Tom Corless Seconded by Lois Duke that a budget of \$300 be approved for the Family Games Night on May  $12^{th}$ , 2018. Carried.

Leah advised that this event will start at 4:00 and include door prizes, a quiz and pizza will be served. Members' children and grandchildren aged 13 and over are encouraged to attend. Because this is a membership drive the National Elks will be asked to provide funding for the event.

# 5. Building Lease

Geoffrey advised that he has asked his nephew who is a lawyer to recommend lawyers who specialize in leases for consideration by the Executive. Geoffrey would abstain himself from this decision.
